**Appearance**

1. No rust on any exposed metal surfaces like: blades or screws.
2. All visible surfaces, logo must be free of pits, chips, cracks, scratches, sink marks, flash, color deviations, and imperfections.
3. Must be free of dirt, debris, and offensive odor: Trimmer, packaging and all accessories.
4. Excess oil should be wiped off of the trimmer.
5. Logo and artwork to be legible.
6. Cord wire tie should be secured around cord and not fall off or allow cord hank to fall apart.

**Construction**

1. All screws must be tight and not stripped.
2. Clipper to have the following approvals:  
CE
3. Charger to have the following approvals:  
CSA
4. Drop test: Drop unit from 3ft. Onto hardwood surface in 3 different orientations. There must be no exposed live parts.
